Action: Approve February 26, 2016 Minutes - Dr. Swearingen moved to approve; approved

Information Items:

EDT 365 Course Change – Dr. Chang reported Early Childhood changed their program and students are no longer required to take ELE 302 and that course is an EDT 365 prerequisite. If RFT does not make changes, their students will not be able to take EDT 365. Dr. Chang spoke with Judy Pickering and Juli Panza to receive a course number that their students take early on which is CFD 260. After their freshman year, they can take the EDT 365 course. Dr. Groves moved to approve, Dr. Hinch second, approved.

EDT Course Proposal – Dr. Jean-Charles reported changes were made to the syllabus. Dr. Jean-Charles reported Jerry Masterson reviewed the proposal and syllabus. The main concern is there is another cyber security course already offered and don't want any confusion. Part C is going to be cloud based networking. Need to get corrected copy of proposal from Dr. Jean-Charles. Need to talk to CIS Department to make sure this course is not in conflict with their course and to receive approval/endorsement. Discussion ensued. Dr. Pearman and Dr. Jean-Charles will meet with the CIS Department head. Dr. Sheffield moved to table.

New Literacy Program faculty – Dr. Swearingen reported Pam Correll will be joining RFT Department in the fall. She is finishing her doctorate at University of Kentucky.

MID program change and EDC 249 were approved by College Council.

Hill Hall renovation – Move the week after graduation in May 2017 and move back in August 2018. People will be moving to PCOB, Glen Isle, or somewhere on campus. There is no set design, the building will not get bigger, and any suggestions are welcome. Boxes will be provided and we will pack. \$11 million dollars available.
